



MEMORANDUM

Sub:- Guidelines for issuing "No-objection certificate" in respect of Medical Officers of Tripura Health Services/Tripura Medical Education(Faculty and condition) services for appearing in Post Graduate Entrance Examinations in different courses of study.

Besides, the sponsored guideline the following guidelines have been laid down for issuing "No-objection Certificate" in respect of Medical Officers of Tripura Health Service and Tripura Medical Education Services under the Health & Family Welfare Department, Government of Tripura for appearing in Post Graduate Entrance Examinations in different courses of study in Medical Colleges in and outside the State as open category candidate.

2. The eligible criteria for 'No-Objection Certificate' are as under:-
 - a) A candidate must be working under Tripura Health Services.
 - b) Upper age limit shall be 45(forty five) years for UR candidates, 5(five) years relaxable for SC & ST candidates.
 - c) Should be pursuing a PG course in any clinical/pre and para clinical subject from a MCI recognized Medical Institutions.
3. 'No-Objection Certificate' shall be valid for 1(one) year.
4. CONDITIONS.
 - a) Open category candidate (regular & ad-hoc) will have to complete a minimum period of 6 (six) months service under this Department.
 - b) For sponsored category, candidates will have to complete 3(three) years of rural service, including 1(one) year in TTAADC areas.
 - c) In case of regular cadre of THS/TMES, release/admissible leave may be sanctioned as per Govt. norms if the candidate selected before sponsored criteria is fulfilled.
 - d) In case of regular cadre completed 3(three) years services but not fulfilled the sponsored criteria will be released/sanctioned admissible leave as per Govt. norms.
 - e) In case of ad-hoc, no Medical Officer of THS/TMES will be sanctioned any kind of leave except admissible leave if selected for PG course.
5. In the event of selection in Post Graduate course of study, candidates will have to execute necessary bond under this Department as per Memorandum NO.7(10)-DME/ET/2012, dated 30-10-2015.
6. No-Objection Certificate shall be issued by DHS for THS cadre and DME for TMES cadre after taking necessary approval from competent authority.
